The Classified Records product is a separate, optional solution that is installed and used with Gimmel Compliance Suite (Cs). Organizations wanting to use this functionality must first install and configure Gimmel Compliance Suite.

Classified records extend the Compliance Suite's RMA Record and all functionality present in the latter is also available for Classified Records. Classified Records has extended security controls that can be graded by an authorized user manually or automated by the system.

Classified Records has been developed in accordance with the DoD 5015.2 Chapter 3 - Management of Classified Records and is certified to this standard (<http://jitc.fhu.disa.mil/projects/rma/reg.aspx>).

Gimmel Classified Records 4.13.1 Release Is Now Available!

Gimmel is pleased to announce the General Availability of Compliance Suite Classified Records (CR) 4.13 for SharePoint 2013/2016. The Classified Records 4.13.1 release provides compatibility with Compliance Suite 4.13 and with SharePoint 2013 and SharePoint 2016.

This release is a simultaneous release with Gimmel Compliance Suite 4.13.1 that is supported on the SharePoint 2013/SharePoint 2016 platform.

The Compliance Suite is a series of features that extend SharePoint's Records Center to give your organization a reliable and centralized repository for collaboration and records management that is compliant with both the Baseline and Classified standards of the Department of Defense (DoD) 5015.2 [Records Management Program](#). Classified Records is a separate add-on module that requires Cs to operate.

## What's New

Classified Records has been updated to the 4.13.1 codebase and supports SharePoint 2013 and SharePoint 2016.

## System Requirements

This section describes the software and hardware necessary to install and run Gimmel Classified Records.

### Software

Gimmel's Classified Records requires the following software:

- SharePoint Server 2013 (Standard or Enterprise Edition) with Service Pack 1, or
- SharePoint Server 2016 (Standard or Enterprise Edition) with Service Pack 1
- Microsoft .NET Framework 4.6 or higher installed <https://www.microsoft.com/en-us/download/details.aspx?id=48130>)
- One of the following authentication methods: NTLM, Kerberos, or ADFS
- Compliance Suite 4.13.1

## New Installations

This version supports new installations on SharePoint 2013/2016, as long as the underlying pre-requisites are met.

## Upgrades to Classified Records 4.13.1

This version supports new installations on SharePoint 2013 and SharePoint 2016.

The upgrade path for SharePoint 2016 is: Classified Records V4.11 to V4.13 or V4.13 to V4.13.1

The upgrade path for SharePoint 2013 is: Classified Records V4.12 to V4.13.1 or V4.13 to V4.13.1.

## Interoperability

This version is compatible with Compliance Suite V4.13.1 in SharePoint 2013 and SharePoint 2016. Licensed users may download the software and documentation from the [Gimmel product download site](#).

## Hardware

Gimmel software products are deployed on an existing or new SharePoint environment leveraging existing or planned infrastructure investments. No additional hardware is required. The following Microsoft TechNet article lists the minimum software requirements to install and run Microsoft SharePoint Server [2013](#).

## Issues Addressed and Improvements

Classified Records has been updated to the 4.13.1 codebase and supports SharePoint 2013 and SharePoint 2016. All issues resolved in this release were related to compatibility with Compliance Suite 4.13.1 and do not impact functionality or usability.

## Known Issues

This section provides an overview of the known issues contained in version 4.13.1 of Classified Records.

- Currently, Gimmel is investigating an issue where Classified Records does not work on subsites of site collections. In this situation, the user sees the functionality, but it is not usable.
- There is a sporadic issue where in-application help does not display for Classified Records. Gimmel is investigating this issue. In the meantime, you can download the PDF documentation from the Gimmel software download site if this occurs.
